GOVERNOR'S WORKFORCE DEVELOPMENT DIRECTIVE NO. PY2006-11, Change 1

SUBJECT: Program Year 2007 WIA Youth, Adult, and Dislocated Worker Allocations

- 1. Purpose.** This transmits the USDOL Notice of Obligation reflecting the April 1, 2007 availability for expenditure of a portion of local area formula PY 2007 Youth funds.

- 2. Discussion.** USDOL Grant Agreement AA-16014-07-55-A-1, effective date 04/01/2007, indicates the April 1, 2007, availability for expenditure of a designated portion of Program Year 2007 Youth Program formula funds. Per the enabling legislation, WIA Youth funds may be made available for expenditure prior to the July 1 start date of a WIA Program Year in order to accommodate the workforce development services needs of eligible in-school youth prior to the end date of the academic school year. Information on the specific amounts of PY 2007 Youth funds available for April 1 expenditure is transmitted in Governor's Workforce Development Directive No. PY 2006-11, Attachment 1A, dated April 25, 2007.


